

Dear Friends,

At United Way's core is our belief in valuing, respecting and honoring the dignity of all people. We believe a community thrives when it is united and everyone has equitable access to resources and opportunities for achieving success in life.

Over the last year the pandemic impacted each of us, our families and organizations. It is clear COVID widened disparities and created greater hardships for our most vulnerable residents. As we begin to recover from the pandemic there is much to do. and your continued support will be more important than ever.

As we reflect on 2020, YOUR kind support and generosity had incredible impact:

 Berks Countians received help 290,000 times through the Berks COVID-19 Response Fund. YOU answered the call to action. Last year, \$1,000,000 was raised and provided 50 grants to 41 organizations to help feed, house and provide essential services to those most in need.

• The 2020 Campaign, under the leadership of Sue and Craig Perrotty, successfully raised nearly \$11 million to invest and provide stability to our 80+ high-priority, high-performing programs, initiatives and grants.

 Leadership United was launched to focus on and enhance volunteer recruitment, training and placement for the community. This new division includes Leadership Berks, a new program managed by United Way. Leadership Berks was founded in 1985 through a partnership of

Greater Reading Chamber of Commerce, United Labor Council, Junior League and United Way.

 We were selected as a beneficiary of a \$10 million gift from philanthropist MacKenzie **Scott.** This one-time grant provides the opportunity to extend and accelerate funding for programs that will address systemic issues and create sustainable change. 
Sue and Craig Perrotty provided inspired leadership and unending energy in their roles as Campaign Chairs. Their passion for the community and helping others was the foundation for many campaign successes. They took the lead on recruiting sponsors for the Legacy of Community Leaders Challenge Match to honor the commitment of leaders who committed their time and effort to strengthen our community. Thanks to the generous Challenge Match sponsors, the campaign experienced increased and new giving.



Responding to COVID-19

During the last year we were all impacted by the pandemic, and our daily lives were altered. For too many individuals and families COVID-19 meant new struggles around not having enough food to eat, affording a place to live and other essentials.

United Way quickly established a Berks COVID-19 Response Fund to support critical services delivered by dedicated nonprofits working on the frontlines to help our most vulnerable neighbors. Through YOUR generosity \$1,000,000 was raised in record time. Many contributors took advantage of \$300,000 in Challenge Match funds provided by Customers Bank, The Kindness Coalition Foundation (Karen and John Arnold) and Dena and Vic Hammel — we are grateful for this incredible support.



*Programs supported by the grants include emergency food needs, housing, infant/family essential needs, safety supplies, virtual client services, emergency child care, and child abuse services. Remaining COVID Response Funds were carried over to 2021 to continue to support services for those most impacted by the pandemic.



Several key actions supported community needs:

- United Way supports 211 as a way to connect people to the help they need 24/7. This free and confidential service was needed more than ever as people were immediately impacted by COVID. In 2020, 211 was contacted nearly 9,500 times, representing a 70% increase from 2019. The most common needs from outreach centered on housing, utility assistance, food and health care.
- Nearly 70% of the COVID-19 Response Fund grants supported essential needs including food insecurity and housing/shelter/utility assistance.
- Another grave concern during the pandemic: learning loss and the well-being of children as their daily lives were altered disrupted. To help educators mitigate learning loss and help their students with coping skills, 26 COVID education grants were distributed to 12 school districts to provide supplemental literacy resources, trauma-informed learning for district staff and parental support materials to support remote learning.
- United Way distributed nearly 160,000 PPE and personal care items to 45 nonprofit organization to help staff and clients safe. Special thanks to John and Lisa Gallen/EthoSource, Brentwood Industries and

PhytogenX for their donations of masks, shields and personal care products.

- Partnered with Berks County Community Foundation, Co-County Wellness and County of Berks to support the implementation of COVID-19 contact tracing.
- Collaborated to establish the Homeless Prevention Task Force to respond to emergency and longerterm solutions for preventing homelessness during the pandemic, as well as supporting a pilot Eviction Prevention Intervention program to help tenants and landlords avoid eviction proceedings in partnership with local Magisterial District Judges.

United Way of Berks County was surprised and grateful to be one of the recipients of a gift from author and philanthropist MacKenzie Scott at the end of 2020. She donated \$4.2 billion to 384 high performing organizations across the U.S. to support increased needs from the pandemic and to help the most vulnerable persons in communities; United Way of Berks County received \$10 million.

This gift does not replace annual campaign dollars, but instead provides new funding for immediate COVID-related needs and targeted longer-term systemic change.

An Advisory Committee, comprised of United Way board members and community volunteers, was established to provide guidance and a framework for putting the funds to work in Berks County. Ultimately, United Way Board of Directors approve the distribution of the funds. The Advisory Committee established a three-part plan for the grant:

- **COVID RESPONSE GRANTS** continue to support increased demand for services to help those most impacted by the pandemic meet their basic needs.
- **IMPACT GRANTS** support programs/ collaborative efforts to expand programming and capacity to serve the community's most vulnerable individuals and families.
- FOCUSED GRANTS multi-year grants addressing systemic issues and creating sustainable impact will be awarded following a process involving research, community conversations and the development of specific requests for proposals.

OCIC partnered with the 18th Wonder Improvement Association on a Victory Garden project, and families received garden materials and plants to grow some of their own food. The project encouraged home food gardening and increased food security.

Oakbrook Collective Impact Council

The Oakbrook Collective Impact Council (OCIC) remained strong during 2020. United Way partnered with Berks Community Health Center and created a shared outreach position to develop relationships with OCIC Resident Ambassadors and to assist with neighborhood activities and events.

Additional 2020 OCIC highlights include:

- Partnered with Penn State Racial and Ethnic Approaches to Community Health (REACH) to support outreach with residents via surveys and focus groups
- Promoted flu vaccination clinics and connected residents to resources during COVID
- Created welcome baskets filled with home essentials for new Oakbrook residents
- Supported Victory Garden project and distributed garden
- kits to area families
 Offered training for Resident Ambassadors on community leadership and team building leadership and team building

While everything about 2020 was different, the commitment to care for each other remained the same. Nearly 150 Day of Caring volunteers participated in 20 projects to improve and strengthen Berks County. Now, that's LIVING UNITED!



Kids Succeed!

When COVID struck, all schools closed and Ready.Set.READ! Star Readers, an in-school tutoring program, was also paused. Whether schools remained virtual, returned to the classroom or established a hybrid structure, the Star Readers program required a new approach in the COVID environment. United Way worked with Schuylkill Valley School District to pilot Vello, a virtual tutoring program. Vello safely connects students and trained volunteer tutors online and utilizes a virtual library tailored to each student's skill level. Teachers monitored progress and reported participating students maintained or increased reading skills.



Turning the Pages to Success in Berks County Chris Brennan, a volunteer tutor, worked with Carson an eight-year-old student. During her sessions with Carson, she observed him connecting to books and the characters in the stories they read together. Carson's reading skills progressed and he advanced to a higher reading level. While tutoring virtually was different, Chris shared the program still fosters enjoyment for reading and she continues to find tutoring a rewarding experience.

Ready.Set.READ! Programs

Star Readers • Growing Readers • Read With Me • Reach Out And Read Opening Doors/Abriendo Puertas • Neighborhood Bridges

The GROWING READERS program is focused on kindergarten readiness for children enrolled in childcare centers located in the City of Reading. A critical strategy of the program is supporting professional development for the Early Childhood Educators (ECEs) in the centers in partnership with Reading Area Community College (RACC). United Way staff recruits and supports the ECEs as they attend classes at RACC to receive credits and prepare for obtaining their Child Development Associate (CDA), a nationally recognized credential.

2020 Highlights:

- Due to COVID-19, classroom curriculum delivery shifted to online learning and assignment/program requirements completion.
- 92% of the enrolled students completed the required courses and are eligible to apply for the CDA credential.

Since the program's inception, 29 ECEs have obtained the CDA credential; 54 ECEs have completed RACC courses and 19 ECEs are in the process of completing RACC courses. COVID delayed the CDA process and the ECEs are committed to gaining new skills to help their Pre-K students become better prepared for school.



Did You Know? Children who do not participate in learning or literacy activities over the summer lose up to 2½ months of learning from the previous school year? United Way's Books for Bikes program is designed to combat summer learning loss. Thanks to the support of Customers Bank and program partners, Alvernia University's South Reading Youth Initiative and YMCA of Reading, 95 kids earned a new bike and helmet after successfully completing the 2020 program.

In a year of firsts, RSR partnered with Read Alliance, based in New York City, to pilot a virtual literacy program with members of Olivet Boys & Girls Club. The program provided local teens with a paid work experience over the summer to tutor elementary-age children. The teen tutors worked with their students on reading and literacy activities. The benefits of the program included meaningful connections between teens and children, workforce experience for teens and supplemental literacy support children in kindergarten, first or second grades. Teens were paid through a partnership with the Young Adults Program at PA CareerLink Berks County. The collaboration was supported by Customers Bank.




